**PROGRAM BEYOND THE BACCALAUREATE FOR THE

Candidates for the Ph.D. degree will have successfully completed the following requirements: 1. coursework equivalent to approximately 60 hours; 2. satisfactory completion of comprehensive examinations; and 3. examinations in two foreign languages. A typical coursework program would include the following:

Ethnomusicology students are required to pass a language proficiency examination in one major world language (e.g. Mandarin, Hindi, Spanish, Portuguese, Arabic) and a second foreign language related to

the area of research, both to be approved by petition to the Division. Additional language study may be necessary, depending on the focus of the student's research. The first language requirement should ideally be fulfilled by the end of the second semester of residence. The second language requirement must be fulfilled before advancement to candidacy for the doctoral degree, and ideally by the end of the fifth semester of residence.
